Thanks for the email. Herenga ā Nuku Aotearoa's funding for 2024-25 has remained the same as it was for 2023-24. We made several budget cuts last year in response to cost pressures. We are carrying 1 staff vacancy and 2 vacancies in our contracted network of regional field advisors, but we do not have plans to leave those vacancies empty. Cost pressure means that we will need to reduce some expenditure again for the coming year, but we do not have plans for job cuts or for significant cuts to services.

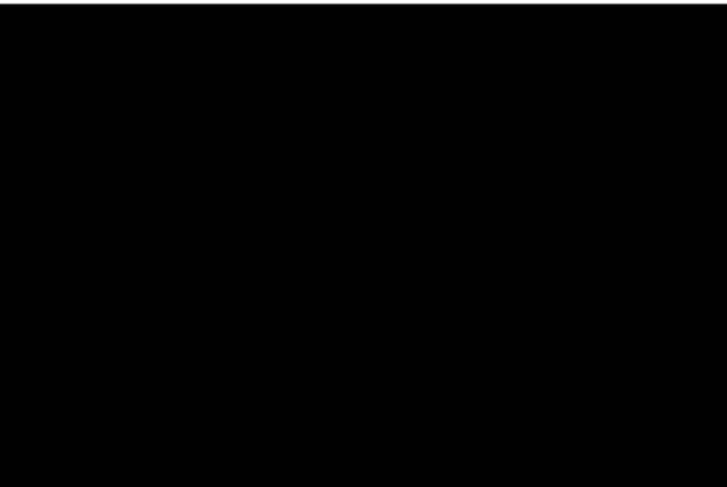
I'm getting in touch today, following the release of Budget 2024, to please confirm the extent of your agency's job cuts and cost-savings measures in the public sector.
