In the last financial year, Herenga ā Nuku Aotearoa, the Outdoor Access Commission, paid Meta \$1408.76 including GST, for advertising on Facebook and Instagram. We spent \$11.56 including GST, advertising on Google. We did not pay for advertising on the other platforms you listed. We also spent \$1665.50 including GST, with Lifestyle Publishing Limited to advertise on Wilderness Magazine's online platforms—website and email newsletters.	
Herenga ā Nuku did not use an agency to manage that advertising. We did have an account with later.com, which helped us place content, but the advertising itself was done directly with Meta.	
Herenga ā Nuku did not create any 'custom audience' lists as part of our advertising.	
Herenga ā Nuku has not had any meetings, in person or by other methods, with any representative from Meta, Google, LinkedIn, or TikTok in the last year. We do not have dedicated account managers with any of those platforms.
